 - b. County to inspect meter base for code before calling Duke
 - 2. Duke Energy to install Junction box
 - a. Located at Gainsway Dr & Paddock Rd. southeast corner by streetlight. They will bore under street to reach the meter base and breaker box located near pond
 - b. Timeline 2-3 week time from to connect power
 - c. Cost \$220.00
 - d. Contact person at Duke Jesse Johnson (736-2018)
 - 3. Hoosier Irrigation to install irrigation

- a. Will install once all above done
- b. Rough cost estimate \$5000.00
- c. Industrial heads why increase in price from previous estimates.
